## **WORKSHOP ITEMS**;

 The first workshop was held on the merger of Walker Neighborhood Park with the Wangenheim Playing Fields. Following a brief introduction by Yovanna Lewis of the Public Works Dept., the workshop was led by Andy Stratton Reese, RLA a consultant for Rick Engineering.

The discussion focused on the increased **Playing Fields** with baseball back stops, **Field** and **Security Lighting**, **Off Street Parking** from Flanders Drive, **Restroom Building** including storage space and a concession stand for league use, **Shade Sales** over the existing playground, **ADA Sidewalks** connecting the new parking lot with the sidewalk by the playground and the Black Mountain Rd. sidewalk, **Fencing** as required by SDUSD with a **Gated Main Entrance** close to the pedestrian cross walk from the Miramar Collage Parking lots and **Signage** at the new main entrance and Flanders drive.
