- 2. Tammy Luu, representative from the TET festival, invited and wanted support from the Mira Mesa Recreation Council to attend their upcoming TET festival taking place January 27-29, 2017. The organization the festival is run through, Vietnamese American Youth Alliance, promotes youth leadership.

- 1. The Hourglass Joint Use Committee discussed the following:
 - a. The college installed three electric vehicle charging stations on the Miramar College campus for a two year trial period.
 - b. The college plans to increase the number of sand volleyball courts.
 - c. The college requested the use of the entire gymnasium in May 2017 for their graduation ceremony.

- 1. Jeff Stevens stated he likes the name Jonas Salk Neighborhood Park because of the close proximity to the Jonas Salk Elementary School and what Salk's accomplishments represent.
- 2. Sylvia Ollinger stated she wants the community to know where the parks are geographically located and then name them geographically. She stated she prefers the named person be someone that has passed away and not someone currently alive. She also stated she wants Wangenheim Joint Use facility to be called Wangenheim Joint Use field because of the geographical location.
